

*Please take notice that the Court en banc issued a Resolution dated **SEPTEMBER 28, 2021**, which reads as follows:*

**“B.M. No. 3795 (Re: Request for Extension of Existing Notarial Commissions)**

**RESOLUTION**

The Court resolves to **NOTE** the letter dated September 3, 2021 of Atty. Rameses Victorius G. Villagonzalo seeking to extend the validity of his notarial commission issued in 2020 and originally expiring on December 31, 2021.

Due to the continuing difficulties imposed by the ongoing health crisis, the Court resolves to extend the validity of **all** notarial commissions which are set to expire on December 31, 2021.

Accordingly, all notarial commissions granted in 2019 and whose validity had been previously extended until December 31, 2021 pursuant to the Court’s December 1, 2020 and June 22, 2021 Resolutions are deemed **further extended**, and shall thus remain valid **for an additional period of six (6) months beginning January 1, 2022 until June 30, 2022**.

Further, all notarial commissions granted in 2020 and are originally expiring on December 31, 2021 are also **deemed extended for the same period of six (6) months beginning January 1, 2022 until June 30, 2022**.

During the aforesaid six (6)-month period, the notaries public whose terms are deemed extended pursuant to this Resolution shall continue performing notarial acts using their existing seals.” (adv15)
