The Court resolved to conduct **Oral Arguments** on the above-entitled case on July 2, 2019 at 2:00 p.m.

For the orderly proceeding of Oral Arguments, the parties are required to observe the following guidelines:

I. The parties shall limit their presentation for oral argumentation on the following issues:

I. Procedural Issues

- A. Whether or not petitioners violated the doctrine of the hierarchy of courts when they filed the Petition with this Court, instead of the Court of Appeals, which has concurrent jurisdiction over writs of *kalikasan*.
- B. Whether or not petitioners failed to exhaust administrative remedies when they failed to give notice to respondents, as required by Section 138 (c) of the Philippine Fisheries Code, before the filing of the Petition.
- C. Whether or not petitioners failed to comply with Rule 7, Section 2 of the Rules of Procedure for Environmental Cases considering that several petitioners failed to sign the verification.
- D. Whether or not petitioners state a cause of action.
- E. Whether this case presents a justiciable issue.

II. Substantive Issues

- A. Whether or not the issuance of a writ of *kalikasan* is the proper remedy for the enforcement of Philippine environmental laws against foreign nationals and/or respondents in Ayungin Shoal (Second Thomas Shoal), Panganiban Reef (Mischief Reef), and Panatag Shoal (Scarborough Shoal), or is the remedy political or diplomatic in nature.
- B. Whether or not, under the Rules of Procedure for

Environmental Cases for the issuance of a writ of continuing mandamus:

- B.1. Petitioners have alleged sufficient basis for the issuance of the writ.
- B.2. This Court has the jurisdiction to require the continuing compliance of respondents in the enforcement of Philippine environmental laws in Ayungin Shoal (Second Thomas Shoal), Panganiban Reef (Mischief Reef), and Panatag Shoal (Scarborough Shoal).
- C. Whether or not petitioners have sufficiently discharged their burden of proof and evidence to support the grounds for their requested reliefs.
- D. Whether or not the parties are entitled to the reliefs they requested.

- a. The Parties will be heard in the following order:
 - 1. Petitioners
 - 2. Respondents
- b. Each side will be invited to summarize their opening statements in five (5) minutes before they will be interpellated by the Justices.
- c. In case there will be more than one lawyer that will argue for a party, the lead counsel shall determine how to share this time allocation with their co-counsels.
- III. The interpellation by the Members of the Court will immediately follow after each presentation of arguments.
- IV. The time allotted for counsels to argue shall be exclusive of the time devoted to interpellation by the Members of the Court.
- V. The Members of the Court maintain their privilege to ask any question on any relevant matter or require submission of any document necessary for an enlightened resolution of this case.
- VI. Written copies of opening statements, tables of authorities, copies of any document to be presented and all slide presentations, if any, should be submitted to the Clerk of Court no later than 12:00 o'clock noon of Monday preceding the date of the oral arguments, or July 1, 2019. The parties should submit one (1) original, fourteen (14) printed copies, and digital copies in accordance with the Resolution dated September 10, 2013 in A.M. No. 10-3-7-SC. All opposing parties should also be served with these documents and slide presentations. All submissions will be posted in the Supreme Court website immediately before the oral arguments.

- VII. All other matters not covered by the oral arguments but properly raised in the pleadings shall not be considered eliminated as issues, but shall be discussed and argued in the written memoranda to be required of the concerned parties.
- VIII. All parties are advised to strictly comply with the Efficient Use of Paper Rule in A.M. No. 11-9-4-SC dated November 13, 2012, especially with respect to Supreme Court bound papers.
- IX. The Parties should file their respective memoranda within a **non-extendible** period of ten (10) days from the close of oral arguments.
