RE: 2022 2ND SEMESTER (July to December 2022) PROCUREMENT MONITORING REPORT

Under Section 12.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the Bids and Awards Committee shall prepare a Procurement Monitoring Report (PMR) in the form prescribed by the Government Procurement Policy Board (GPPB). The PMR shall cover all procurement activities specified in the Annual Procurement Plan, whether ongoing and completed, from the holding of the pre-procurement conference to the issuance of notice of award and the approval of the contract, including the standard and actual time for each major procurement activity.

The PMR shall be approved and submitted by the Head of Procuring Entity to the GPPB in electronic format within fourteen (14) calendar days after the end of each semester. The approved PMR shall likewise be posted in the agency website accordance with GPPB Resolution No. 11- 2020 dated 20 May 2022.
