
Please take notice that the Court, Second Division, issued a Resolution dated August 31, 2022 which reads as follows:

“JIB FPI No. 21-002-SC (Febella J. Guillermo, Supreme Court Supervising Judicial Staff Officer and Officer-in-Charge, Accounting Division, Financial Management Office, Office of the Court Administrator, *complainant* v. Emmanuel U. Bautista, Accountant III, Bookkeeping Section, Accounting Division, Financial Management Office, Office of the Court Administrator, *respondent*). — The Court **RESOLVES** to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendation of the Judicial Integrity Board in the attached Report and Recommendation¹ dated October 22, 2021 and the Report² dated May 25, 2022. Accordingly, the administrative complaint against Emmanuel U. Bautista, Accountant III, Bookkeeping Section, Accounting Division, Financial Management Office, Office of the Court Administrator, is hereby **DISMISSED**. However, he is **ADMONISHED** to be more circumspect in his action and **STERNLY WARNED** that a repetition of the same and similar infractions in the future shall be dealt with more severely.

Moreover, the Chief of the Security Division of this Court is: (a) **DIRECTED** to investigate the possible lapses in the Court’s security administration; (b) **ENJOINED** to strictly implement the preventive, corrective, and other security measures under Security Guidelines for the Supreme Court dated July 18, 1989; and (c) **ORDERED** to submit a compliance report within ten (10) days from notice.
