

CONTRACT AGREEMENT FOR THE CONSTRUCTION OF THE JUDICIAL RECORDS OFFICE DOCKET AND SUPREME COURT ONE-STOP SHOP COUNTERS AT THE SC QUADRANGLE, NEW MAIN BUILDING [RE-BIDDING]

THIS AGREEMENT, made this _____ day of _JAN 27 3923, 2023 between THE SUPREME COURT OF THE PHILIPPINES, with principal office at Padre Faura Street, Ermita, Manila (hereinafter called the "Entity") and ABEIAN CONSTRUCTION of #005 Poblacion, Burgos, Ilocos Norte 2918 (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Procurement of a Works Contractor for the Construction of the Judicial Records Office Docket and Supreme Court [SC] One-stop Shop Counters at the SC Quadrangle, New Main Building [Re-Bidding] with identification number IP No. 2022-03 (hereinafter called "the Works") and the Entity has accepted the Bid for Nine Million Four Hundred Forty-two Thousand Eight Hundred Thirty-two Pesos and 17/100 (\$\mathbb{P}9,442,832.17)\$, by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz*.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the

bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Nine Million Four Hundred Forty-two Thousand Eight Hundred Thirty-two Pesos and 17/100 (₱9,442,832.17), or such other sums as may be ascertained, ABEIAN CONSTRUCTION agrees to the Procurement of a Works Contractor for the Construction of the Judicial Records Office Docket and Supreme Court [SC] One-stop Shop Counters at the SC Quadrangle, New Main Building [Re-Bidding] in accordance with its Bid.
- 4. **THE SUPREME COURT OF THE PHILIPPINES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
