
*Please take notice that the Court, Second Division, issued a Resolution dated **August 31, 2022** which reads as follows:*

“A.C. No. 11144 [Formerly CBD Case No. 17-5340] (*Sonie Crisostomo-Gacay, Complainant v. Atty. Omar B. Francisco, Respondent*). — The Court **NOTES** the Integrated Bar of the Philippines (IBP) Board of Governors’: (1) Notice of Resolution dated May 19, 2018 in CBD Case No. 17-5340 which adopted the findings of fact and recommendation of the Investigating Commissioner to impose upon respondent the penalty of suspension from the practice of law for one month; and (2) Notice of Resolution dated February 16, 2019 in CBD Case No. 17-5340 which granted respondent’s motion for reconsideration of the Notice of Resolution dated May 19, 2018, and recommended instead the dismissal of the complaint against the respondent.

The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendations of the Director for Bar Discipline in the attached Extended Resolution¹ dated July 18, 2020, which the Integrated Bar of the Philippines Board of Governors likewise adopted and approved. The Complaint against Atty. Omar B. Francisco is **DISMISSED**.
