
*Please take notice that the Court, Second Division, issued a Resolution dated **June 27, 2022** which reads as follows:*

**A.C. No. 11361 [Formerly CBD Case No. 19-6045] (Jayson O. Pangilinan, et al., complainants v. Atty. Josabeth V. Alonso and Atty. Vladimir del Rosario, respondents)** – The Court **NOTES** the Notice of Resolution No. CBD-XXV-2021-11-16 dated November 19, 2021 of the Integrated Bar of the Philippines (IBP) Board of Governors which resolved to adopt the findings of fact and recommendation of the Investigating Commissioner dated May 26, 2021 to dismiss the complaint; transmitted by letter dated March 1, 2022 of Director Avelino V. Sales Jr., Commission on Bar Discipline, IBP, together with records of the case.
