
Please take notice that the Court, Second Division, issued a Resolution dated August 3, 2022 which reads as follows:

“A.C. No. 13479 [Formerly CBD Case No. 18-5687] (ALMA GRACE L. SARRA-ADAPANG, Complainant v. ATTY. OSCAR A. CORPUZ, JR., Respondent). — The Court **NOTES** the Integrated Bar of the Philippines (IBP) Board of Governors’ (1) Notice of Resolution No. CBD-2021-04-10¹ dated April 10, 2021 which adopted and approved the Report and Recommendation² dated December 19, 2019 of the Investigating Commissioner to dismiss the case for lack of merit; and (2) Notice of Resolution No. CBD-XXV-2022-01-05³ dated January 22, 2022 which denied complainant’s Motion for Reconsideration and upheld the Board of Governor’s Resolution dated April 10, 2021; both transmitted by letter dated March 30, 2022 of Director Avelino V. Sales, Jr., IBP Commission on Bar Discipline, together with the records and flash drive file of the case.

The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendations of the Investigating Commissioner in the attached Report and Recommendation dated December 19, 2019, which the Integrated Bar of the Philippines Board of Governors likewise adopted and approved.
