
*Please take notice that the Court, Second Division, issued a Resolution dated **October 12, 2022** which reads as follows:*

“OCA IPI No. 21-5113-RTJ (Romeo D. Delos Reyes, Complainant v. Hon. Ma. Rowena Violago Alejandria, Presiding Judge, Branch 121, Regional Trial Court, Caloocan City, Respondent). — The Court **NOTES** (1) the affidavit-complaint dated December 22, 2020 of Romeo D. Delos Reyes against Hon. Ma. Rowena V. Alejandria, Presiding Judge, Regional Trial Court (*RTC*), Branch 121, Caloocan City, for gross ignorance of the law and manifest delay in the administration of justice; and (2) the verified comment dated February 17, 2021 of respondent Presiding Judge Ma. Rowena V. Alejandria.

The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendation of the Judicial Integrity Board in the attached Report dated May 25, 2022 (Annex “A”). Accordingly, the Court **DISMISSES** the complaint against Hon. Ma. Rowena V. Alejandria, Presiding Judge, *RTC*, Branch 121, Caloocan City for lack of factual and legal basis.
