Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated February 13, 2023 which reads as follows:

"G.R. 262017 (Catherina P. Aledron* v. Crown Lifestyle Net, Inc. and Rafael King). — This Petition for Review on Certiorari¹ (Petition) filed under Rule 45 of the Rules of Court by petitioner Catherina P. Aledron (petitioner) seeks to reverse and set aside the Decision² promulgated on 13 September 2021 and the Resolution³ dated 16 March 2022 of the Court of Appeals (CA) in CA-G.R. SP No. 13532. The CA affirmed with modification the ruling of the National Labor Relations Commission (NLRC) which deleted the payment for backwages and the solidary liability of respondent Rafael King. The NLRC, however, ordered respondent Crown Lifestyle Net, Inc. to pay petitioner the amount of ₱38,226.65 representing her holiday pay, 13th month pay, service incentive leave pay, moral and exemplary damages and attorney's fees.

Considering the allegations, issues, and arguments presented, the Court finds no cogent reason to deviate from the consistent findings of the lower courts and resolves to **DENY** the instant Petition for failure of petitioner to sufficiently show any reversible error in the challenged Decision and Resolution rendered by the CA.

However, We find it proper to modify the ruling of the CA, affirming the findings of the NLRC, and impose legal interest at the rate of six percent (6%) per *annum* on the total monetary awards due to petitioner consistent with jurisprudence,⁴ reckoned from finality of this Resolution until fully satisfied.

WHEREFORE, premises considered, the instant Petition is **DENIED.** Accordingly, the assailed Decision dated 13 September 2021 and the Resolution dated 16 March 2022 of the Court of Appeals in CA-G.R. SP No. 13532 are **AFFIRMED with MODIFICATION** in that legal interest at the rate of six percent (6%) per *annum* is imposed on the total monetary awards granted in favor of petitioner Catherine P. Aledron amounting to ₱38,226.65, representing her holiday pay, 13th month pay, service incentive leave pay, moral and exemplary damages, and attorney's fees, reckoned from finality of this Resolution until full payment.
