Resolution No. 2022-42

**RE: AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF ONE (1) UNIT PASSENGER /
UTILITY VAN FOR HAULING AND DELIVERIES
FOR THE LOWER COURTS (RE-BIDDING)**

WHEREAS, the Court, in its resolution in A.M. No. 22-04-03-SC (*Re: Procurement of One (1) Unit Passenger / Utility Van for Hauling and Deliveries for the Lower Courts*) dated 20 September 2022, granted the SC-BAC-GS authority to conduct a re-bidding for the *Procurement of One (1) Unit Passenger / Utility Van for Hauling and Deliveries for the Lower Courts* with an Approved Budget for the Contract (ABC) in the amount of One Million Eight Hundred Twenty Thousand Pesos (₱1,820,000.00);

WHEREAS, on the basis of the said authority, the conduct of the Pre-Procurement Conference on 25 October 2022 and the finalization of the technical specifications and bidding documents, the SC-BAC-GS caused the posting of the Invitation to Bid on 28 October 2022 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, two (2) prospective bidders participated in the Pre-Bid Conference on 08 November 2022, namely:

1. B. M. Domingo Motor Sales Inc. (Isuzu Bulacan – Meycauayan Branch)
2. Isuzu Pasig

WHEREAS, B. M. Domingo Motor Sales Inc. purchased the bidding documents in the amount of Two Thousand Pesos (₱2,000.00);

WHEREAS, B. M. Domingo Motor Sales Inc. submitted its bid within the deadline set on 22 November 2022;



WHEREAS, the following were the results of the preliminary examination and evaluation of bids during the opening of bids on 22 November 2022:

ABC = ₱1,820,000.00

B. M. Domingo Motor Sales Inc.	PASSED	₱1,790,000.00

WHEREAS, the detailed technical evaluation was conducted by the implementing office, Motorpool Section, Property Division, Office of the Administrative Services, Supreme Court, on B. M. Domingo Motor Sales Inc.'s technical proposal. In the Certification dated 29 November 2022, the implementing office, thru Mr. Martin L. Erme, Mechanic II, Motorpool Section, Property Division, Office of Administrative Services, Supreme Court, found that upon review, the technical proposal submitted by B. M. Domingo Motor Sales Inc. was compliant with the required specifications;

WHEREAS, the financial bid of B. M. Domingo Motor Sales Inc. in the amount of One Million Seven Hundred Ninety Thousand Pesos (₱1,790,000.00) was declared by the SC-BAC-GS as the *Single Calculated Bid*, subject to the post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to B. M. Domingo Motor Sales Inc. on 07 December 2022, which upon its receipt, submitted the required documents on 12 December 2022;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS, with the conformity of the representatives of the implementing office and the Property Division, Office of Administrative Services, Office of the Court Administrator, on the basis of B. M. Domingo Motor Sales Inc.'s documentary submissions and other available sources. The Post-Qualification Report on B. M. Domingo Motor Sales Inc. dated 22 December 2022 was submitted to the SC-BAC-GS for its consideration;


WHEREAS, after review and evaluation of the findings of the post-qualification team on B. M. Domingo Motor Sales Inc.'s submissions, the SC-BAC-GS found that B. M. Domingo Motor Sales Inc. has met the requirements of the Supreme Court and declared its bid as the *Single Calculated and Responsive Bid*;




NOW THEREFORE, We, the members of the SC-BAC-GS, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. recommend the **AWARD** of the **Contract for the Procurement of One (1) Unit Passenger / Utility Van for Hauling and Deliveries for the Lower Courts (Re-bidding)** to **B. M. DOMINGO MOTOR SALES INC.** in the amount of **ONE MILLION SEVEN HUNDRED NINETY THOUSAND PESOS (P1,790,000.00)**; and
2. request that **HON. RAUL B. VILLANUEVA, Court Administrator**, be authorized to sign, for and in behalf of the Court, the contract with **B. M. DOMINGO MOTOR SALES INC.**


