**RE: AWARD OF THE CONTRACT FOR THE  
PROCUREMENT OF ORACLE DATABASE  
ENTERPRISE EDITION FOR THE OFFICIAL USE  
OF THE MANDATORY CONTINUING LEGAL  
EDUCATION OFFICE**

**WHEREAS**, the SC-BAC-GS received the 1<sup>st</sup> Indorsement dated 13 September 2022 from the Procurement Planning Committee relative to the *Procurement of Oracle Database Enterprise Edition for the Official Use of the Mandatory Continuing Legal Education Office* with an Approved Budget for the Contract (ABC) in the amount of One Million Six Hundred Eighty Thousand Six Hundred Twenty Four Pesos and 18/100 (P1,680,624.18), inclusive of all taxes;

**WHEREAS**, on the basis of the said indorsement, conduct of the Pre-Procurement Conference on 04 October 2022 and the finalization of the technical specifications and bidding documents, the SC-BAC-GS caused the posting of the Invitation to Bid on 04 November 2022 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

**WHEREAS**, two (2) prospective bidders participated in the Pre-Bid Conference on 15 November 2022, namely:

1. Radenta Technologies Inc.
2. DBQuest, Inc.

**WHEREAS**, both prospective bidders purchased the bidding documents in the amount of Two Thousand Pesos (P2,000.00);

**WHEREAS**, both prospective bidders submitted their respective bids within the deadline set on 15 November 2022;



**WHEREAS**, the following were the results of the preliminary examination and evaluation of bids during the opening of bids on 15 November 2022:

**WHEREAS**, the detailed technical evaluation was conducted by the Management Information Systems Office (MISO) on Radenta Technologies Inc.'s technical proposal. In its report dated 01 December 2022, the MISO found the technical proposal of Radenta Technologies Inc. fully compliant to the technical requirements;

**WHEREAS**, the financial bid of Radenta Technologies Inc. in the amount of One Million Four Hundred Seventy Thousand Five Hundred Forty Six Pesos (₱1,470,546.00) was declared by the SC-BAC-GS as the *Lowest Calculated Bid*, subject to the post-qualification process;

**WHEREAS**, the notice for submission of post-qualification documents was issued to Radenta Technologies Inc. on 07 December 2022, which upon its receipt, submitted the required documents on 12 December 2022;

**WHEREAS**, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS, with the conformity of the representatives of the MISO and the Mandatory Continuing Legal Education Office, on the basis of Radenta Technologies Inc.'s documentary submissions and other available sources. The Post-Qualification Report on Radenta Technologies Inc. dated 14 December 2022 was submitted to the SC-BAC-GS for its consideration;

**WHEREAS**, after review and evaluation of the findings of the post-qualification team on Radenta Technologies Inc.'s submissions, the SC-BAC-GS found that Radenta Technologies Inc. has met the requirements of the Supreme Court and declared its bid as the *Lowest Calculated and Responsive Bid*;




**NOW THEREFORE**, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:


1. recommend the **AWARD** of the *Contract for the Procurement of Oracle Database Enterprise Edition for the Official Use of the Mandatory Continuing Legal Education Office* to **RADENTA TECHNOLOGIES INC.** in the amount of **ONE MILLION FOUR HUNDRED SEVENTY THOUSAND FIVE HUNDRED FORTY SIX PESOS (P1,470,546.00)**; and
2. request that **ATTY. JESUSA JEAN D. REYES, Executive Officer, Mandatory Continuing Legal Education Office**, be authorized to sign, for and in behalf of the Court, the contract with **RADENTA TECHNOLOGIES INC.**
