Requests / Inquiry	Response
Are you allowing Managed Service or is this a supply and delivery?	No, Managed Service is not allowed. This project requires supply and delivery.
What is the contract term?	Please refer to the Schedule of Requirements in the bid documents.
Is there a requirement for the UPoE?	Regular PoE can be used.
Will you require certification training or basic knowledge transfer for the firewall?	Comprehensive training is required.  Certification training is very much welcome and preferred, but not required.
May we request to allow submission of contract for Network Switches as acceptable similar contract?	Yes, as long as the main contract is for Enterprise Wi-Fi.
May we request to extend the schedule to up to 150 days after the acceptance of the Project Plan?	



Kindly advise if the requirement means automations for policy control and response.	No.
Please advise if up to 40°C operating temperature is acceptable.	Yes.
Is this supposed to be an Access Point features? (must support at least 16 SSIDs)	Yes.
Is the outdoor AP required to also have a built-in omnidirectional antenna?	Yes.
Is the transceiver for the proposed switch or for the existing firewall?	It is for the proposed firewall.
May we request that the switching capacity be set at 1.68Tbps/2.4 Tbps?	No.
May we request that a generic but equivalent stand be provided? (UPoE+)	As discussed during the Pre-bid Conference, PoE will be accepted.
How many ISPs are there?	Initially, there is one (1).
Will there be a S2S connection to be established?	Initially, there is none.
What is your preferred HA?	Initially, Active-Passive.
