
*Please take notice that the Court, Second Division, issued a Resolution dated **August 10, 2022** which reads as follows:*

“A.C. No. 13482 [Formerly CBD Case No. 15-4484] (*Wilma L. Zamora, complainant v. Atty. Makilito B. Mahinay, respondent.*) – The Court **NOTES** the Integrated Bar of the Philippines (IBP) Board of Governors (1) Notice of Resolution No. CBD-2020-08-34 dated August 22, 2020 which approved and adopted the Report and Recommendation dated October 15, 2018 of the Investigating Commissioner to dismiss the case after finding the recommendation to be fully supported by the evidence on record and the applicable laws and rules; and (2) Notice of Resolution No. CBD-XXV-2022-01-14 dated January 22, 2022 which denied the motion for reconsideration of the complainant and upheld the Board of Governors’ Resolution dated August 22, 2020 to dismiss the complaint for lack of merit.
