FINAL NOTICE TO COMPLY WITH THE MCLE AND UPDATED LIST OF COMPLIANT LAWYERS

Considering the end of the extension of the 7th MCLE Compliance Period on 14 April 2023, the MCLE Governing Bord has authorized the posting of the updated list of lawyers who are compliant with the MCLE up to the 7th Compliance Period as of the said date. You may view the list from the MCLE website at mcle.judiciary.gov.ph, the IBP website at www.ibp.ph, the myIBP App, and the Supreme Court website at sc.judiciary.gov.ph.

Further, this serves as a **FINAL NOTICE TO COMPLY** with the MCLE 7th Compliance Period within sixty (60) days from the date of this publication.

If your name does not appear in the list but you have already complied with the 36-credit unit requirement, please submit your Attorney's Compliance Report¹, while those who have ground/s for exemption are required to file an Attestation/Application for Exemption² with supporting documents.

Please note that only those who have actually been issued a Certificate of Compliance/Exemption on or before 14 April 2023³ are included in the list. Those who may have completed the required number of units or have submitted an Application/Attestation of Exemption shortly on or near the end of the extension may not be included in the list, due to any of the following reasons:

- Non-submission or late submission of Attendance Reports and/or Attorney's MCLE Compliance Reports (ACRs) by the respective providers or the concerned lawyers themselves;
- 2. Non-payment of prescribed fees or penalties, if any; and,
- 3. Application/Attestation of Exemption is still subject to evaluation and/or approval by the MCLE Governing Board.

Rest assured that all submissions which are complete and in order shall be considered and acted upon during the sixty (60)-day period provided for in the Notice for Final Compliance.

Following this listing of compliant lawyers, the list of **non-compliant** lawyers will be published after the sixty (60)-day period provided above pursuant to the provisions of Rule 12, Bar Matter No. 850 and Court Resolution A.M. No. 19-10-10-SC (Re: MCLE Governing Board Resolution No. 06-2019 [Resolution Authorizing the Publication in Newspapers of General Circulation of the Names of
