NOTICE

Sirs/Mesdames:

*Please take notice that the Court, Third Division, issued a Resolution dated **January 11, 2023**, which reads as follows:*

“G.R. No. 252590 – ALBERTO S. DEE, *Petitioner*, v. RICARDO S. DEE, TERESITA M. DEE, MINORS KLAUS JURGEN, PHILIP DIMITRI, ET AL., *Respondents*.

The Court resolves to:

(1) **NOTE** the Compliance with Manifestation of respondents-spouses Ricardo S. Dee and Teresita M. Dee (**Spouses Dee**), dated May 5, 2022;

(2) **NOTE** the Entry of Appearance with Manifestation of respondents Klaus Jurgen, Philip Dimitri, and Amirah Kathrina, all minors and all surnamed “Peter,” represented by their father Gernot Peter (collectively, the **Peter Children**), dated July 13, 2022;

(3) **RECALL** that:

(a) The Court issued, on September 14, 2020, a Resolution requiring respondents to Comment on the Petition;

(b) Subsequently, the Court issued a Resolution, dated May 3, 2021, requiring petitioner Alberto S. Dee (**Alberto**) to furnish the Court with the current address of Gernot Peter (**Gernot**) in light of the fact that the copy of the earlier September 14, 2020 Resolution sent to Gernot was returned unserved;

(b) Alberto then filed a Compliance/Manifestation dated July 22, 2021, stating that he was not aware of the whereabouts of Gernot

and simply relied on the records of the case in the lower court for the address of Gernot that was provided in the Petition;

(d) Thereafter, a Resolution, dated February 14, 2022, was issued by the Court noting the Compliance/Manifestation, dated July 22, 2021, and requiring counsel for the Spouses Dee to furnish the Court with the address of Gernot;

(e) The Compliance with Manifestation of the Spouses Dee was filed on May 5, 2022, providing the address of Gernot;

(f) The Entry of Appearance of the Peter Children was filed on July 13, 2022, stating that their prior counsel of record had died some time ago, and since then they had not received any court processes concerning the case;

(4) **REITERATE** the directive in the Court's Resolution, dated September 14, 2020, requiring the Peter Children to file their Comment on the Petition;

(5) **FURNISH** the Peter Children with copies of the Petition for Review, dated May 22, 2020; and

(6) **REQUIRE** the Peter Children to file their Comment within a non-extendible period of fifteen (15) days from receipt of this Resolution.
