NOTICE TO THE 2023 BAR APPLICANTS

Re: REFUND MECHANICS FOR THE 2023 BAR APPLICATION FEE

Pursuant to Bar Bulletin No. 2, Series of 2023,¹ the 2023 Bar Application Fee of Php 12,800.00, once paid, is **non-refundable**. Requests for refund due to "change of mind" and other similar unmeritorious reasons shall <u>not</u> be entertained.

However, in *exceptional* cases, an applicant may submit a request for refund through the "Payment - Refund Request" section of the OBC's 2023 Helpdesk Form² and upon submission of all the corresponding documentary requirements within the prescribed deadline, depending on the ground for refund.

Please see below the allowable grounds for refund of the 2023 Bar Application Fee and their corresponding requirements and deadlines:

- c. Details of the bank account where the amount to be refunded will be deposited:
 - i. Bank name, preferably Landbank,⁵
 - ii. Branch name,
 - iii. Account name, and
 - iv. Account number; and
- d. Six-digit *InstaPay* or *BancNet* reference number, if paid through other banks;
- 2. Erroneous payment email from Unionbank;
- 3. Successful payment email from Unionbank; and
- 4. Electronic Official Receipt (e-OR) issued by the Supreme Court and generated in BARISTA.

Failure of New Applicants to successfully complete their law degrees⁶ after payment of the 2023 Bar Application Fee

The following supporting documents must be compiled into one PDF file and uploaded along with the request sent *via* OBC Helpdesk:

 Notarized Affidavit of withdrawal of Bar application and request for refund of the 2023 Bar Application Fee, addressed to the Office of the 2023 Bar Chair, indicating the following:

- a. Registered name in BARISTA;
- b. Bar Examinee Number;
- c. Details of the bank account where the amount to be refunded will be deposited:
 - i. Bank name, preferably Landbank],⁷
 - ii. Branch name,

3. Documentary proof (*e.g.*, medical certificate, etc.) to adequately substantiate the applicant's highly meritorious reason (not limited to medical issues).

The sufficiency of the "highly meritorious reason" alleged by the applicant, the evaluation of the application for refund under this ground, and the amount that may be refunded to the applicant if so granted shall be subject to the discretion and determination of the Office of the 2023 Bar Chair.

Only applicants covered by the grounds enumerated above and who shall lodge their completely-documented requests for refund within the prescribed deadlines shall be entitled to apply for a refund of their previously paid 2023 Bar Application Fee. Requests for refund filed with incomplete documents or beyond their respective deadlines shall <u>not</u> be processed.

The *notarized* Affidavit of withdrawal of Bar application and request for refund of the 2023 Bar Application Fee filed under the second and third grounds for refund, once acknowledged as received by the OBC, **shall deem the application irrevocably withdrawn**. Withdrawing applicants are presumed to have understood and to have been fully informed of the implications and repercussions of their actions and shall be bound thereby. The withdrawal of application, however, shall not constitute an automatic approval of the request for refund.

Please be advised that this Notice applies only to claims for refund of the <u>2023</u> Bar Application Fees and does not cover or address requests for refund of application fees paid for the previous years of Bar Examinations.
