Kindly be advised that the Venue Selection is on a **first come**, **first-served basis**. You may choose your preferred Local Testing Center (LTC) <u>only</u> on your scheduled date and time.

Failure to select your preferred LTC within the scheduled period will constitute a waiver on your part. You will then be assigned to an LTC in the province or region nearest your present address or law school, depending on slot availability. You will be informed of your final assigned LTC no later than July 28, 2023.
