Please take notice that the Court, Third Division, issued a Resolution dated June 14, 2023, which reads as follows:

“A.C. No. 10924 [Formerly CBD Case No. 16-5093] (Ronnie F. Faulve, *Complainant*, versus Atty. Rodolfo M. Elman, Atty. Marco Anacleto P. Buena, and Atty. Quintin J. Pedrido, Jr., *Respondents*.) – The Notice of Resolution No. CBD-2020-10-13 dated October 10, 2020 of the Board of Governors of the Integrated Bar of the Philippines (IBP) is **NOTED**. Considering that the findings and conclusions of the IBP Board of Governors are in accord with applicable laws and duly supported by the evidence on record, the Court **ADOPTS** and **ACCEPTS** its recommendation to dismiss the Complaint against Atty. Rodolfo M. Elman, Atty. Marco Anacleto P. Buena, and Atty. Quintin J. Pedrido, Jr., for lack of merit.

Complainant Ronnie F. Faulve is hereby **ORDERED** to **SHOW CAUSE** within ten (10) days from notice why he should not be held liable for indirect contempt for his propensity to file baseless and frivolous complaints against members of the bar, including government lawyers who did not act in his favor.¹
