Sirs/Mesdames

Please take notice that the Court, Third Division, issued a Resolution dated April 27, 2022, which reads as follows:

“G.R. No. 207509 (YANG WEN YI, a.k.a. “ANDY YANG,” Petitioner, **v. PEOPLE OF THE PHILIPPINES,** Respondent). — In light of news articles¹ stating that Yang Wen Yi, also known as “Andy Yang,” was found guilty of violating Section 8 of Republic Act No. 9165, and to maintain judicial economy and efficiency, the parties are required to move in the premises within a non-extendible period of 20 days upon receipt of this order to inform this Court:

- a) The status of the criminal case against petitioner; and,
- b) Whether the status of the criminal case has rendered the Petition before this Court questioning the denial of petitioner’s application for bail, moot.

The parties may make further manifestations as may be warranted relating to the legal issues in this case.
