Please take notice that the Court, Third Division, issued a Resolution dated March 8, 2023, which reads as follows:

G.R. No. 253296 – PEOPLE OF THE PHILIPPINES, Plaintiff-Appellee, v. XXX,* Accused-Appellant.

After a review of the Decision,¹ dated February 21, 2020, of the Court of Appeals (CA), in CA-G.R. CR-HC No. 12220, and the Decision,² dated November 5, 2018, of the Regional Trial Court, Branch 194, Parañaque City, in Criminal Case Nos. 14-1134 and 14-1135, the Court resolves to **DENY** the appeal³ for failure of the accused-appellant XXX to sufficiently show that the CA committed a reversible error to warrant the exercise of the Court's discretionary appellate jurisdiction.

WHEREFORE, the appeal filed by accused-appellant XXX is **DENIED**. The Decision, dated February 21, 2020, of the Court of Appeals, in CA-G.R. CR-HC No. 12220, is **AFFIRMED**.
