This Bid Bulletin is hereby issued to modify or amend the items in the bidding documents for the Negotiated Procurement (Two Failed Biddings) of the Detailed Architectural and Engineering Design (DAED) Consultant of the Manila Hall of Justice Project published on 28 September 2023. This Bid Bulletin serves to notify all parties concerned of the following clarifications on the Terms of Reference for the present Project:

I. Paragraphs 3 and 4 of Item I. Pre-Design Phase, A. Technical Aspects, 1.A.2. Architectural Concepts, found in page 99 of the bidding documents, is hereby amended to read as follows, with the inserted phrase highlighted for ease of identification:

The Design Study Report was developed using information gathered from the site analysis report, **the Functional Design Brief** (hereto attached as ANNEX "A"), and the findings and recommendations of the National Commission for Culture and the Arts (ANNEX "B"), and in consultation with key stakeholders. The Design Study Report includes the Basis of Design, Design Parameters, and the Finalized Functional Design Brief, which were the bases in developing a range of harmonized architectural design concept options using techniques and developments in space planning, and architectural and engineering designs. However, the Court will provide a revised/updated Functional Design Brief (ANNEX "C") and the matrix of requirements for the minimum area of typical offices and other essential offices and amenities (ANNEX "C-1") to be used by the Consultant in developing the new Architectural and Engineering Design Report.

Annexes A, B, C, and C-1 are herein attached for your reference.

II. As regards the scale model, Item 5, II. Design Phase, A. Technical Aspects, II.A.2. Final Documentation Stage, found in Page 104 of the bidding documents, is hereby clarified and amended to read thusly:

(5) Scale Model. The Consultant shall fabricate or cause the fabrication of a scale model of the approved design with a 1:100 scale; and
