Invitation to Bid for the Procurement for the Supply, Delivery and Installation of Various Information and Communication Technology (ICT) Equipment for the First and Second Level Courts

1. The Supreme Court, through the Judiciary Development Fund, intends to apply the total sum of Nine Hundred One Million Two Hundred Thirty Five Thousand Seven Hundred Eighty Pesos (\$\mathbb{P}901,235,780.00)\$, inclusive of all taxes and freight charges, being the Approved Budget for the Contract (ABC) to payments under the contracts for the Procurement for the Supply, Delivery and Installation of Various Information and Communication Technology (ICT) Equipment for the First and Second Level Courts - ITB No. 2023-40, consisting of three (3) lots, with the corresponding ABCs, to wit:

Lot & Description	ABC
Lot 1: National Capital Region (NCR) and Luzon Area	₱514,296,760.00
Lot 2: Visayas and Mindanao Area	₱240,486,520.00
Lot 3: Laptops	₱146,452,500.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The **Supreme Court** now invites bids for the above Procurement Project. Delivery of the Goods is required and must be in accordance with Section VI. Schedule of Requirements of the Bidding Documents. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from SC-BAC-GS Secretariat and inspect the Bidding Documents at the address given below during office hours from Mondays to Fridays at 9:00 AM to 3:00 PM.
- 5. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

The Supreme Court will hold a Pre-Bid Conference on January 9, 2024 (Tuesday), at 1:00 p.m., through video conferencing or webcasting via Microsoft Teams, which shall be open to prospective bidders.

In order to participate in the Pre-Bid Conference, interested bidders shall send a letter of intent (via electronic mail) containing the names and email addresses of interested participants on or before January 9, 2024 (Tuesday), 10:00 a.m. Kindly coordinate with the SC-BAC-GS Secretariat prior to said date for further details and instructions.

- 7. Bids must be duly received by the SC-BAC-GS Secretariat through manual submission at the office address indicated below on or before January 23, 2024 (Tuesday), 10:00 a.m. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on January 23, 2024 (Tuesday) at the given address below and/or via Microsoft Teams. The following is the schedule of the opening of bids:
