
*Please take notice that the Court, Second Division, issued a Resolution dated **July 10, 2023** which reads as follows:*

“**JIB FPI No. 22-143-P (Noel C. Samaniego, Complainant, v. Mark Anthony T. Reyes, Sheriff III, Municipal Trial Court in Cities, Gapan City, Nueva Ecija, Respondent).** — This Court **NOTES**: (1) the Verified Complaint¹ dated June 30, 2022 of Noel C. Samaniego, charging Mark Anthony T. Reyes, Sheriff III, Municipal Trial Court in Cities (*MTCC*), Gapan City, Nueva Ecija, with dereliction of duty, culpable violation of the law, and grave abuse of discretion relative to Small Claims Case No. 244 [*Raquel Sta. Ines v. Lutgarda Samaniego*], Small Claims Case No. 245 [*Raquel Sta. Ines vs. Lutgarda Samaniego*], and Small Claims Case No. 246 [*Dolores Raquel Sta. Ines Salvador v. Lutgarda Samaniego*]; and (2) the Verified Comment² dated September 6, 2022 of respondent Mark Anthony T. Reyes.

This Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendation of the Judicial Integrity Board in its Report³ dated April 26, 2023. Accordingly, this Court **DISMISSES** the complaint against Mark Anthony T. Reyes, Sheriff III, MTCC, Gapan City, Nueva Ecija for lack of merit.
