*Please take notice that the Court, Second Division, issued a Resolution dated **November 6, 2023** which reads as follows:*



PAUIG, COURT STENOGRAPHER 1, MUNICIPAL TRIAL COURT IN CITIES, TUGUEGARAO CITY, CAGAYAN, BRANCH 1, Respondent).** — The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendations of the Judicial Integrity Board in the attached Report¹ dated August 4, 2023.

The Complaint against **Hon. Vilma T. Pauig** is **DISMISSED** for being judicial in nature and for utter lack of merit. The complaint against **Marilyne G. Pauig** is similarly **DISMISSED** for utter lack of merit.
