
*Please take notice that the Court, Second Division, issued a Resolution dated **November 8, 2023** which reads as follows:*

“JIB FPI No. 23-250-P (ANONYMOUS COMPLAINT AGAINST A STAFF [a.k.a. Jane Doe] OF BRANCH 7, HALL OF JUSTICE, BACOLOD CITY, NEGROS OCCIDENTAL). – The Court **NOTES** the (1) the anonymous complaint dated March 27, 2023, filed against a staff member of Branch 7, Hall of Justice, Bacolod City, Negros Occidental for engaging in corruption and irregular activities, and (2) the letter dated September 4, 2023 of Ms. Ruth A. Dizon, Clerk of Court II, Municipal Trial Court in Cities, Branch 7, Bacolod City, stating that she has been with the Judiciary for thirty-five [35] years and will be retiring effective September 5, 2023, but she cannot process her retirement pension with the Government Service Insurance System[GSIS] because of the instant case filed against her, and praying that the administrative case filed against her be dismissed at the earliest time possible and a corresponding clearance be issued to facilitate her retirement claims with the GSIS.

The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendations of the Judicial Integrity Board in the attached Report¹ dated September 6, 2023. Accordingly, the Court **DISMISSES** the complaint against a staff member of Branch 7, Hall of Justice, Bacolod City, Negros Occidental for lack of merit.
