TECHNICAL TRAINING  
FOR THE 2024 *SHARI'AH* BAR EXAMINATIONS

In light of the digitalization of the 2024 *Shari'ah* Bar Examinations (2024 SBE), all examinees intending to take the same are required to undergo the technical training integrated into the ongoing *Shari'ah* Training Seminar (STS), including those who previously completed it. The technical training will familiarize the examinees not only with the basic aspects of using a laptop, but also with navigating the interface of the examination software, including using the assigned passwords, downloading the questionnaire, answering the questions, and uploading one's answers.

Participants must bring to the technical training the laptops that they plan to use during the Bar days. This session will serve as an opportunity to check the hardware and software compatibility of their devices. Participants are required to have their laptops fully charged when they attend the session.

The technical training will be conducted by the Management Information Systems Office (MISO) of the Supreme Court in the regions and cities as follows:
