May we request to Supreme Court of the Philippines to consider submitting of two (2) or more similar contracts, the aggregate contract amount should be equivalent to at least 50% of the total ABC of the lot/s to be bid. The largest of these similar contracts must be equivalent to at least 25% of the total ABC of the lot/s to be bid.	Denied.
For filing cabinet with four (4) drawers, please specify the dimensions required For storage cabinets and bookshelves, please check the width dimension of storage cabinet and bookshelf. If this is wrong, please specify the correct dimension.	Please refer to the revised technical specifications above.
