COMPLIANCE

(Re: Resolution dated July 5, 2022)

Respondents, through the OFFICE OF THE SOLICITOR GENERAL (OSG), in compliance with the Honorable Court's Resolution dated July 5, 2022, respectfully manifest that upon verification of the records of the OSG, the Department of Justice, and the Regional Trial Court of Makati, Branches 148 and 150, the status of the cases below are as follows:

1. *People of the Philippines v. Antonio F. Trillanes IV*
Criminal Case No. 07-3126
RTC-Makati City, Branch 150

The RTC-Makati City, Branch 150's Orders dated September 25, 2018 and December 18, 2018 granting the People's Very Urgent Ex-Parte Omnibus Motion for the Issuance of Hold Departure Order and Alias Warrant of Arrest against Trillanes were the subject of a Petition for Certiorari, Prohibition, and Injunction filed by Trillanes (CA-G.R. SP No. 159811).

During the status hearing on June 22, 2021, the RTC-Makati City, Branch 150 declared the case dismissed by

2021 in CA-G.R. SP No. 159811, granting Trillanes' Petition for Certiorari, Prohibition, and Injunction.

2. *People of the Philippines v. Antonio F. Trillanes IV*
Criminal Case No. 03-2784
RTC-Makati City, Branch 148

No hearings are conducted by the RTC-Makati City, Branch 148 due to the Order dated October 22, 2018 denying due course to the People's Very Urgent Ex-Parte Omnibus Motion for the Issuance of Hold Departure Order and Alias Warrant of Arrest against Trillanes, and accordingly affirming the dismissal of the case per Order dated September 21, 2011.

The Order dated October 22, 2018 and Joint Order dated November 22, 2018 were the subject of the People's Petition for Certiorari (CA-G.R. SP No. 159217).

3. *Antonio F. Trillanes IV v. Hon. Elmo A. Alameda, in his capacity as Presiding Judge, Regional Trial Court of Makati City, Branch 150, Office of the City Prosecutor of Makati City, and/or Department of Justice*
CA-G.R. SP No. 159811, Sixth Division
(Criminal Case No. 07-3126)

On March 1, 2021, the Court of Appeals promulgated its Decision granting Trillanes' Petition. Accordingly, the Orders dated September 25, 2018 and December 18, 2018 issued by the RTC-Makati City, Branch 150 in Criminal Case No. 07-3126 are set aside and vacated.

4. *People of the Philippines v. Hon. Andres Bartolome Soriano, in his capacity as Presiding Judge of Branch 148 of the Regional Trial Court of Makati City, and Senator Antonio Trillanes IV*
CA-G.R. SP No. 159217, Special Eleventh Division
(Criminal Case No. 03-2784)

On March 31, 2021, the Court of Appeals promulgated its Decision denying the People's Petition. Accordingly,

the Order dated October 22, 2018 and Joint Order dated November 22, 2018 issued by the RTC-Makati City, Branch 148 in Criminal Case No. 03-2784 are sustained.

5. *People of the Philippines v. Antonio F. Trillanes IV*
G.R. No. 256078
(CA-G.R. SP No. 159811)

In its Resolution dated September 14, 2021, the Honorable Court resolved to:

- a. Note the Manifestation dated July 22, 2021 filed by Trillanes, stating that due to oversight and/or inadvertence, two parties were not furnished with copies of the comment and to rectify this, copies of the comment are served on Prosecutor General Benedicto A. Malcontento and the Presiding Judge of the RTC-Makati City, Branch 148,
- b. Grant the Motion for Leave to File Reply (to the comment on the petition) dated August 1, 2021 filed by the OSG,
- c. Note the aforesaid Reply dated August 1, 2021.

6. *People of the Philippines v. Antonio F. Trillanes IV*
G.R. No. 256660
(CA-G.R. SP No. 159217)

In its Resolution dated April 5, 2022, the Honorable Court resolved to note the Manifestation dated March 10, 2022 filed by the OSG, stating that it already received Trillanes' Comment/Opposition on/to the petition and has already filed a reply thereto on October 25, 2021.
