MANIFESTATION WITH REITERATIVE MOTION (FOR THE ISSUANCE OF TEMPORARY RESTRAINING ORDER AND/OR STATUS QUO ANTE ORDER)

Petitioners **SMARTMATIC TIM CORPORATION** ("Smartmatic TIM") and **SMARTMATIC PHILIPPINES**, **INC.** ("Smartmatic PH") (collectively, the "Petitioners" or "Smartmatic"), by counsel, respectfully state:

1. On 18 December 2023, Petitioners filed a Manifestation and Supplement to the Petition for Certiorari dated 6 December 2023 (With Application for the Issuance of a Status Quo Ante Order) ("Manifestation and Supplement") to inform this Honorable Court of the developments subsequent to the filing of the Petition for Certiorari (with Extremely Urgent Application for the Issuance of a Temporary Restraining Order and/or Writ of Preliminary Injunction) with Urgent Motion for Special Raffle dated 6 December 2023 (the "Petition").

2. As previously manifested before this Honorable Court, during the submission of bids on 14 December 2023, the Special Bids and Awards Committee ("SBAC") refused to accept the bidding documents of a joint venture comprised of SMMT-TIM 2016 Inc., Smartmatic Holdings Inc., and Jarltech International Inc., ("Smartmatic JV"), a separate entity from Smartmatic TIM Corporation ("Smartmatic TIM") and Smartmatic Philippines, Inc. ("Smartmatic PH").¹

3. On the same date, the opening of bids proceeded with the participation of only one (1) bidder - Miru Systems ("Miru"). Following the declaration of a failed bidding due to Miru's failure to comply with the requirements under Republic Act ("R.A.") No. 9184 and its Implementing Rules and Regulations ("2016 IRR"), the SBAC then announced that bidding would be conducted anew on 4 January 2024 (subsequently moved to 8 January 2024).²

4. On 8 January 2024, the COMELEC and the SBAC again proceeded with the bid submission where the SBAC Secretariat confirmed that, upon instructions by the COMELEC and pursuant to the COMELEC's Resolution dated 29 November 2023 ("Assailed Resolution"), it refused to accept the bid of Smartmatic JV.³ Again, with the sole participation of Miru, as the lone bidder, the SBAC proceeded to open the bid and subsequently declared Miru as eligible.⁴ The SBAC is now set to proceed with the post-qualification process.

5. As a result of its exclusion from the procurement proceedings, Smartmatic JV was unable to participate and submit a bid that would possibly be the most advantageous to government. In this

regard, Smartmatic JV had its bidding documents all ready and prepared for submission with the goal of preserving the integrity of its potential bid, but, as mentioned above, the same was denied receipt by the COMELEC even just for safekeeping.

6. Thus, the baseless exclusion of a bidder may have put the integrity of the competitive bidding process in question as any deficiencies in the submissions of parties are best determined under a truly competitive environment, as irregularities in the bidding documents would have otherwise been spotted and raised by a bidder.

7. To emphasize, government procurements are governed by the principles of transparency, competitiveness, streamlined procurement process, accountability and public monitoring.⁵ In *Public Estates Authority v. Bolinao Security and Investigation Service, Inc.*,⁶ this Honorable Court held that "competitive public bidding aims to protect the public interest by giving the public the best possible advantages through open competition," and that "[i]t is a mechanism that enables the government agency to avoid or preclude anomalies in the execution of public contracts." Clearly, the purpose of competitive bidding is to encourage as many participants as possible in order to ensure that the public secures the best bid.

8. It bears noting that following the submission, opening and evaluation of bids, Miru shall still undergo post-qualification assessment to determine whether it complies with all the requirements and conditions specified in the bidding documents.⁷ Thereafter, Miru, upon notice, must be required to submit to the SBAC its latest income and business tax returns, and other appropriate licenses and permits required by law and stated in the bidding documents.⁸ Miru may still be disqualified if it fails to submit any of the post-qualification requirements on time, or if the SBAC finds doubt on the veracity thereof.⁹ It is only after the completion of the post-qualification process that a Notice of Award may be issued to the winning bidder.¹⁰

9. As the procurement process for the 2025 Automated Election System ("AES") has not yet been fully concluded, it is prayed that this Honorable Court intervene to enjoin any award resulting from the flawed bidding.

10. In this respect, Smartmatic, respectfully reiterates its prayer for the issuance of a temporary restraining order, a *status quo ante* order, and the issuance of an order annulling any and all proceedings which proceeded/will proceed pursuant to the implementation of the Assailed Resolution.

PRAYER

WHEREFORE, Petitioners SMARTMATIC TIM CORPORATION and SMARTMATIC PHILIPPINES, INC., respectfully pray that:

1. Pending consideration of the Petition, **ISSUE** a **TEMPORARY RESTRAINING ORDER** and/or **WRIT OF PRELIMINARY INJUNCTION**, effective from the date of its issuance until such time as the decision in this case attains finality, enjoining Public Respondent Commission on Elections *En Banc* and anyone acting for or under its authority, direction, control, or instruction, and any other entity, including the Special Bids and Awards Committee for the 2025 AES, from performing any act in connection with or pursuant to the *Resolution* dated 29 November 2023 giving effect to the disqualification of Smartmatic and/or its related entities, and such other act in connection with, or pursuant to, the *Resolution* dated 29 November 2023.

2. ISSUE a STATUS QUO ANTE ORDER to allow Smartmatic and/or its related entities to participate in the procurement process for the 2025 AES, and prevent the COMELEC and/or SBAC from performing any further act/s which would preempt this Honorable Court's resolution on the Petition.

3. **ISSUE** an **Order ANNULING** any and all proceedings which have proceeded/will proceed pursuant to the implementation of the *Resolution* dated 29 November 2023.

4. ISSUE a Writ of Certiorari ANNULING, REVERSING ,and SETTING ASIDE the *Resolution* dated 29 November 2023 for having been issued with grave abuse of discretion amounting to lack or excess of jurisdiction.
