LOCAL TESTING CENTERS, VENUE ASSIGNMENT,
EXAMPLIFY USER GUIDE, and REFUND MECHANICS

The 2024 Bar Examinations shall be simultaneously conducted in Local Testing Centers (LTCs) across the country. The social and economic benefits of providing regional sites for the examinations cannot be overemphasized. This innovation reduced the logistical, financial, and emotional burdens of bar candidates from the provinces. This #BarNiJLo2024, the Court established 6 LTCs in the National Capital Region (NCR), 2 LTCs in Luzon, 3 LTCs in Visayas, and 2 LTCs in Mindanao, *viz.*:

In the process of venue assignment, the Court considered the examinees' preference of LTCs subject to availability of slots. The examinees can check their assigned LTCs in the Bar Applicant Registration System and Tech Assistance (BARISTA). All examinees must first read and consent to the Closed Circuit Television Notice before accessing this information.


